



## CURTIS PARK SWIM TEAM REGISTRATION 2019

Returning swimmers are guaranteed a position ONLY if they register at either of our **Returning Swimmer Registration** nights at Chick-fil-a, 1094 International Pkwy, Fredericksburg, VA 22406 (on Warrenton Rd), on **April 10<sup>th</sup>** (5:00-8:00pm). No registrations for new swimmers will be taken at that time. The only exception will be for family members of returning swimmers.

New swimmers and returning swimmers (who miss the Returning Swimmer Nights) can register at our **New Swimmer Night** to be held **May 14<sup>th</sup>** at Chick-fil-a, 1094 International Pkwy, Fredericksburg, VA 22406 (on Warrenton Rd) (5:00-8:00pm). There will be no priority for returning members who register at the New Swimmer Night. All new swimmers must also attend a try-out, tentatively scheduled for the first week of night practices May 28-31, at the Mark Lenzi Pool in Curtis Park. All registrations must take place in person: No mail-in registrations will be accepted.

**Eligibility:** Swimmers Age 5-18 years. Swimmers must be able to complete a 25 yard swim. Age group determined by age as of June 1, 2019.
